## TRANSPORTATION COMMISSION OF WYOMING

The Transportation Commission of Wyoming met in the Commission Room of the Transportation Headquarters building in Cheyenne on October 23, 2008. The meeting was convened at 8:30 a.m. by Vice Chair Dziardziel. The following members were present constituting a quorum:

Also present at and participating in the meeting were: Delbert McOmie, Chief Engineer; Pat Collins, Assistant Chief Engineer of Engineering and Planning; David Stearns, Financial Services Administrator; Tom Loftin, Support Services Administrator; Colonel Sam Powell, Wyoming Highway Patrol Administrator; Dennis Byrne, Aeronautics Administrator; Kevin Hibbard, Budget Officer; Doug McGee, Public Affairs Manager; Doug Moench, Senior Assistant Attorney General; and Phil Miller, Division Administrator, Federal Highway Administration.

Those absent: Commissioner Charlie Monk, Lovell; and Tim Hibbard, Assistant Chief Engineer of Operations.

1. Vice Chair Dziardziel presided over the meeting, as Chairman Hawkins was not feeling well.

2. Secretary Scott advised that Agenda Item 6.e.2 - Briefing on Recommended Interstate 80 Safety Improvements should be moved under the Chief Engineer's report, and would become Agenda Item 11.b.

It was recommended by Secretary Scott, moved by Commissioner Latta, seconded by Commissioner McCormick, and carried to approve the agenda changes.

3. It was recommended by Secretary Scott, moved by Chairman Hawkins, seconded by Commissioner McCormick, and carried to approve the minutes from the September 16, 2008, budget presentation, and the September 18, 2008, regular business meeting.

4. Del introduced Messrs. John Smith, Tribal Transportation Officer, and Howard Brown, Assistant Tribal Transportation Officer; Ms. Keja Whiteman, Fremont County Commissioner; Mr. Dave Pendleton, Fremont County Road and Bridge Superintendent; and Ms. Shelby Carlson, WYDOT District Engineer. Mr. McOmie advised that the 17-Mile Road project began about 20 years ago. Over time, the Department has worked closely with the Wind River Tribal Council, Fremont County representatives, the Federal Highway Administration, and Wyoming's Congressional Delegation to accomplish the project.

Ms. Carlson presented the accident history for the 17-Mile Road, West Section. Ms. Whiteman advised that Comprehensive Road Improvement Plan (CRIP) funding is being sought for the last section of the project. Once completed, 14 miles of roadway will be taken off the state system and 11.4 miles will be taken off the county system. Mr. Smith advised that the Tribal Council has worked with WYDOT for years to improve public safety. According to Mr. Smith, the Wind River Reservation has the highest percentage of deaths per capita in the nation. Increased traffic counts from area casinos and narrow roadway and shoulders must be addressed for safety reasons. The 17-Mile Road is a primary route for commerce and school bus traffic to and from the Reservation, and traffic is bumper-to-bumper during peak hours.

The total project cost is estimated at \$19 million. If approved, funding will come from fiscal year 2009 CRIP funds, discretionary funds, and Federal Highway Administration funds.

It was recommended by Mr. McOmie, moved by Commissioner Latta, seconded by Commissioner Covello, and carried to approve a minimum of \$5 million in FY 2009 CRIP funding for the 17-Mile Road (West Section) project. The 17-Mile Road will be moved from the state and county highway systems to the Bureau of Indian Affairs road system upon completion of the project.

Messrs. John Smith, Howard Brown, and Dave Pendleton and Mses. Whiteman and Carlson left the meeting.

5. Director Cox presented the Director's report.

<u>2008 AASHTO Conference</u>: Messrs. McOmie and Collins and Ron Kisicki and John Davis of Management Services attended the 2008 American Association of Highway and Transportation Officials (AASHTO) Conference held in Hartford, Connecticut, October 16 - 20, 2008. Director Cox was unable to attend the meeting.

Director Cox indicated that compared to many other states, Wyoming is doing fairly well. Most other states are experiencing significant financial challenges. A potential second federal stimulus package may include highway funding. The five-state coalition (Idaho, Montana, South Dakota, Utah, and Wyoming) represented Wyoming's interest well at the meeting. Director Cox expressed his appreciation for Messrs. McOmie, Collins, Kisicki, and Davis for participation in the meeting.

<u>Legislatively-Classified Positions</u>: Approval was recently received from the Governor's Office to transfer five Commission position vacancies to legislatively-appropriated WYDOT programs. Four of the positions are for Driver Services, and one is for the Highway Patrol Overweight and Oversize Loads Office. A new attorney position was also requested to handle WYDOT contract issues in the Attorney General's Contracts Unit. The position will be housed downtown at the State Attorney General's office. WYDOT will fund the position and will transfer a vacant attorney position from the Department to the State Attorney General's office. One other position transfer was requested for the Human Resources Program, but it was denied with the possibility of a future request during the

regular appropriated budget process. Mr. Hibbard advised that salaries for the approved positions will be included in the quarterly budget modification in January 2009.

6. Mr. Kevin Hibbard presented the budget report.

Mr. Hibbard explained that the November 19, 2008, budget meeting with Governor Freudenthal will address only the Department's supplemental budget requests. Many of the supplemental items stem from inflation costs.

Mr. Hibbard stated that 2008 revenues were slightly higher than expected. The Department received its federal mineral royalty income on October 15, 2008.

Local Government Finance Committee Meeting: The Local Government Finance Committee will meet in Casper on Tuesday, October 28, 2008.

The Wyoming Department of Audit will carry a bill to synchronize cities' and counties' fiscal years, July through June. The bill proposes including WYDOT in the change. The Department currently operates on a federal fiscal year, October through September. Mr. Hibbard advised that changing the Department's fiscal year would be a monumental and extremely cumbersome task and would prove to be quite expensive. A list of federal requirements and consequences of the change are being compiled to present to the Committee and to the Department of Audit.

7. Mr. Collins presented the Engineering and Planning report, beginning with the tabulation of bids from the October 16, 2008, letting held in Riverton.

Discussion ensued about the validity of purchasing an Acrow panel bridge. Mr. Collins advised that the Department will realize a cost savings by owning another portable bridge as the expense could be recuperated within a couple of uses. This is due in large part to the cost of leasing rather than owning the bridge.

9. <u>Fiscal Year 2009 Transportation Enhancement Activities - Local (TEAL) Grant Projects</u>: Mr. Collins introduced Mr. C.J. Brown to present the proposed TEAL projects. Mr. Brown introduced Messrs. Steve Achter, FHWA representative, and Ralph Glenn, representing the Wyoming Association of Municipalities (WAM), and Ms. Amber Travsky, WYDOT representative on the TEAL Committee.

Mr. Brown advised that 29 applicants requested some \$7,047,547 in 2009 TEAL grants. Six applications requesting full funding and nine applications requesting partial funding were recommended to the Commission for approval. The total TEAL funding available in fiscal year 2009 was \$2,265,578, including \$265,578 that was carried over from 2008. The TEAL Committee met October 7, 2008, to review the grant requests and to prepare recommendations for 2009.

Messrs. Glenn, Achter, and Brown and Ms. Travsky left the meeting.

15. <u>Briefing on Interstate 80 Tolling Feasibility Study</u>: Mr. Collins briefed the Commission about the I-80 Tolling Feasibility Analysis, a study that was requested by the 2008 Wyoming State Legislature to investigate potential funding remedies for I-80 maintenance. Study results were presented to the Wyoming State Legislature Joint Transportation, Highways and Military Affairs Interim Committee on October 15, 2008, in Cheyenne.

In 2007, WYDOT spent \$8 million to maintain I-80. Fifty percent of I-80 traffic is commercial trucks, and 87 percent of those trucks are through trips (i.e., trips that originate outside of Wyoming). The study also revealed that trucks inflict 99 percent of roadway damage.

The feasibility analysis revealed:

- The current four-lane cross section of I-80 has adequate capacity for current and anticipated traffic volumes;
- Roadway expansion to a six-lane cross section would cost about \$3 billion;
- Tolling can provide necessary maintenance and construction funding; and
- WYDOT must qualify for interstate tolling permission under federal provisions.

Mr. Collins advised that presently a rigorous federal application process is required to get authorization from the FHWA for interstate highway tolling. Under the application process, WYDOT would be required to demonstrate how tolling revenues would be used. The next federal highway bill will very likely provide for more flexibility for tolling on federal interstate highways.

Chairman Hawkins suggested that if tolling is implemented, legislation should give the Transportation Commission jurisdiction over setting toll amounts. Mr. McOmie noted that proposed

tolling revenue would meet anticipated construction needs, and revenue exceeding construction costs would be used for much needed maintenance.

Mr. Collins briefed the Commission about historical and projected Interstate 80 traffic. Traffic counts are expected to more than double in the next 30 years.

<u>2008 AASHTO Meeting</u>: Mr. Collins attended the recent AASHTO meeting in Hartford, Connecticut. He participated in reauthorization discussions while in Hartford. Reporting on the western region meeting that was held in conjunction with the AASHTO meeting, Mr. Collins advised that the Western Governors' Association and the WASHTO states will conduct a freight study on "Freight Flows Estimates and Projections" in the WASHTO states. This work will update a study that was done in 1999 and will include the I-80 corridor. Hopefully, the study will place more emphasis on anticipated I-80 freight needs and will aid the western governors as they seek funding for freight infrastructure needs in the western states.

16. Colonel Powell presented the Highway Patrol report.

The Fatal Crash Summary through September 30, 2008, includes 98 fatal crashes involving 115 deaths. The fatalities include 45 involving rollover crashes, 43 involving multi-car crashes, 22 involving commercial vehicles, 19 involving motorcycles and all-terrain vehicles, 3 involving pedestrians, and 5 involving fixed objects.

There have been 36 crashes to date deemed alcohol related, resulting in 47 deaths. Of those deaths, 37 were attributed to not using restraints.

Of the 115 deaths that have occurred to date in 2008, 65 can be attributed to the non-use of occupant restraints, with 42 involving rollover crashes, 20 involving multi-car collisions, and 3 involving fixed objects. Of the 65 deaths that occurred from non-use of occupant restraints, 46 were Wyoming residents and 19 were non-residents.

<u>Patrol-Investigated Crash Summary</u>: The Patrol-Investigated Crash Summary reflects activity through August 31, 2008. The summary depicts 4,946 crashes statewide, of which 4,101 involved non-commercial vehicles and 845 involved commercial vehicles.

<u>Patrol Field Arrest Activity</u>: Field arrest activity indicates that the majority of arrests made as of September 30, 2008, have been DUI related. Field arrests total 1,730 to date, including:

- DUI arrests from crashes 144
- DUI arrests from traffic stops 811
- DUI arrests from the REDDI Program 148
- DUI arrests from ports-of-entry 7
- NCIC hits (person) 42
- Wyoming warrants hits 135

Colonel Powell noted that multi-fatality crashes increased significantly in September.

Interstate 80 Seasonal Speed Reduction: A seasonal speed reduction plan was implemented in the Elk Mountain (milepost 238) to Arlington (milepost 290) section of Interstate 80 on October 15, 2008. Troopers have been diligently enforcing speed limits in the area. Variable message signs are being used to alert the traveling public of modified speed limits, and Patrol is focusing primarily on educating drivers about the change for now. The Transportation Management Center will gather traffic data over the next month for presentation at a future Commission meeting.

<u>Overweight/Oversize Load Fees</u>: Colonel Powell explained the overweight/oversize load fee comparisons for Wyoming and the surrounding states. According to the fee comparisons, Wyoming's current fees are justified.

17. Mr. Byrne presented the Aeronautics report.

<u>Aeronautics Commission</u>: Mr. Jerry Delano recently resigned his position as Aeronautics Commission Chairman. Mr. Vince Tomassi has assumed the role as chairman, and Mr. Roger Sedum, mayor of Cody, Wyoming, will join the Aeronautics Commission in November.

<u>Aircraft Expenditure Reporting</u>: Mr. Byrne advised a reporting model has been developed for tracking aircraft costs. It will take some time to populate the system with data, but future reports will be developed as the analysis is developed. The system has the capability of reporting all-inclusive costs for owning the State aircraft.

<u>2008 AASHTO Meeting</u>: The AASHTO Subcommittee on Aviation met October 16-17, 2008. The subcommittee is trying to increase its visibility within the AASHTO organization. Aviation, like highways, is seeking a multi-year spending bill for planning purposes.

<u>Select Committee on Air Service Meeting</u>: Mr. Byrne attended a Wyoming State Legislature Select Committee on Air Service meeting in August. A primary discussion topic was the manner in which aircraft charges are handled, particularly when the State planes are flown empty.

18. Mr. Loftin presented the Support Services report.

<u>Driver Services Staffing</u>: Four new field supervisory positions were recently approved for the Driver Services Program. Mr. Loftin commended Mr. Jim O'Connor, former Support Services Administrator, for laying the groundwork toward acquiring the new positions. Supervisors will live in the district where they work.

<u>Real ID Update</u>: Draft legislation was proposed at the Joint Transportation, Highway and Military Affairs Committee (JTC) meeting held in Cheyenne October 15, 2008. The draft bill addresses minimum statutory requirements for Real ID implementation. The JTC voted to sponsor the bill, primarily to prepare the Department should Real ID come to fruition.

Real ID will need to be funded by the Legislature if the program is enacted in Wyoming. A \$500,000 grant has been received so far, which will be used for scanners to scan the documents that are required of the public. About \$60 million in federal funds is available nationwide for future funding. Wyoming will apply for part of that funding.

19. Mr. Stearns presented the Operations report in Mr. Tim Hibbard's absence.

It was recommended by Mr. Stearns, moved by Commissioner Latta, seconded by Commissioner Scott, and carried to approve purchase for bid number 08-0249 to furnish HVAC modifications at the Lusk Rest Area. The bid was awarded to Sheet Metal Specialties, of Casper, Wyoming, for the sum of \$120,700.

It was recommended by Mr. Stearns, moved by Commissioner Covello, seconded by Commissioner Latta, and carried to approve purchase for bid number 08-0250 to furnish 375,000 gallons of liquid and solid anti-icers/de-icer, and 7,500 tons of ice slicer for delivery at various statewide locations. The bid was awarded to Desert Mountain Corporation, of Riverton, Wyoming, for the sum of \$1,238,411.

It was recommended by Mr. Stearns, moved by Commissioner Latta, seconded by Commissioner McCormick, and carried to approve purchase for bid number 08-0265 to furnish 2,812,000 pounds of reflective glass spheres (Type 1) in 50 pound sacks for delivery at various statewide locations. The bid was awarded to Swarco Reflex, Inc., of Mexia, Texas, for the sum of \$728,308.

It was recommended by Mr. Stearns, moved by Commissioner Scott, seconded by Commissioner McCormick, and carried to approve purchase for bid number 08-0266 to furnish 352,215 gallons of traffic line paint for delivery at various statewide locations. The bid was awarded to Ennis Paint, Inc., of Ennis, Texas, for the sum of \$2,705,822.40.

The bid was awarded to Greiner Ford, Lincoln, Mercury, of Casper, Wyoming, for the sum of \$486,532.

It was recommended by Mr. Stearns, moved by Commissioner Covello, seconded by Commissioner Latta, and carried to approve purchase for bid number 08-0278 to furnish five each, new 2009 Ford F150 XL Supercab pickup trucks. The bid was awarded to Greiner Ford, Lincoln, Mercury, of Casper, Wyoming, for the sum of \$96,320.

<u>Adding Compressed Natural Gas (CNG) to WYDOT Fueling Sites</u>: The Governor's Office asked the Department to investigate the feasibility of adding CNG to its state fueling systems. A written report was provided to the Commission. The study revealed that the concept was not feasible because of the complexity of developing a vehicle fleet to cover the cost. In summary, it would take about 50 years for the concept to become economically sound.

20. Mr. McOmie presented the Chief Engineer's report.

<u>2008 AASHTO Meeting</u>: The Federal Highway Administration (FHWA) hosted an array of topics at the annual AASHTO meeting, October 16-20, 2008. One topic of significant concern is that the 2009 Highway Trust Fund may fall short of expectations because of the poor economy. Fiscal year 2010 funding will be depleted, which will impact how Congress addresses future highway funding, as continuing resolutions may not be possible. Another economic stimulus package for highways may be proposed by AASHTO and the FHWA in the future.

<u>I-80 Safety Study</u>: An I-80 safety study was presented at the JTC meeting held in Cheyenne, October 15, 2008. The study analyzed the need for additional snow fence, guardrail, passing lanes on I-80, additional intelligent transportation devices, legislative issues, and other items to improve safety. Approximately \$10.4 million is proposed for funding this year, with an additional \$310 proposed in future years.

October 15, 2008, JTC Meeting: The JTC expressed favor toward a draft bill to implement a state chain law. Eminent domain for snow fence installation was also discussed at the meeting. A draft bill was proposed to increase fines for ignoring road closure gates. The Committee will support a bill regarding the highway logo sign program. Mr. McOmie will work with the Legislative Services Office to draft a bill.

21. Vice Chair Dziardziel recessed the meeting at 11.55 a.m., on Thursday, October 23, 2008.

22. Vice Chair Dziardziel reconvened the meeting at 2:05 p.m., on Thursday, October 23, 2008.

23. Ms. Vicki Nunn of Porter, Muirhead, Cornia & Howard was scheduled to present the results of the 2007 A-133 Department-wide audit but was unable to attend the meeting. Mr. Stearns presented the audit in Ms. Nunn's absence.

It was recommended by Mr. Stearns, moved by Commissioner Latta, seconded by Commissioner Scott, and carried to approve the 2007 audit.

24. It was moved by Commissioner Latta, seconded by Commissioner McCormick, and carried to adjourn the meeting. The meeting was adjourned by Vice Chair Dziardziel at 2:10 p.m., October 23, 2008.
