<b>STEP #3</b>	Plates will be issued numerically in consecutive order and forwarded to the County Treasurer's Office of the county of your choice. Current plates must be surrendered to the Treasurer's office upon issuance of the Wildlife Conservation plate.				
	The fees for this plate are distributed as follows: \$30 to the WYDOT Highway Fund; \$150 to the Wildlife Conservation Fund to be used to provide for conservation efforts related to the transportation system: signage, wildlife corridors, wildlife crossings, game fences, etc. The annual \$50 fee (which will be collected in future years through 2025) is also distributed to the Wildlife Conservation Fund.  To retain eligibility in future years, there is a \$50 annual fee in addition to your regular registration fees.
