RE: Lack of WyoLink Coverage in Park County

To Whom It May Concern:

With the understanding of WyoLink's mission to address the inoperability between first responders and WyoLink's infrastructure desire to provide the necessary communication to those responders within the State, we are writing to ask for an expansion of towers in Sunlight/Crandall and on the Northfork. Dependable communication is key to life safety.

Since January of 2020, there have been 3,152 calls in the Northfork for the Park County Sheriff's Department, the Park County Fire District, Wyoming Highway Patrol, Guardian Flight and Park County Search and Rescue. In the Sunlight and Crandall areas, there have been a total of 728 calls for the Park County Sheriff's Department, the Park County Fire District, West Park Hospital, Guardian Flight and Park County Search and Rescue which illustrates that there is a need for WyoLink communication among the various responders in these areas.

Both are in areas of high tourism and the resulting need to provide services to travelers. In addition, the Northfork has approximately 1,600 buildings and the Sunlight/Crandall area has about 1,450. So, in addition to tourism and seasonal travelers, there are also residences and businesses that require the same sort of life safety measures. There is a continued influx of new residencies in these two areas.

First responders in these areas are having issues with coverage and there are large gaps with regard to communication in these areas since the shift has been made to WyoLink. I have visited with a number of the stakeholders and agencies that are impacted by this communication breakdown in these areas and we write to you today to share our support for an expansion of towers in the Northfork and Sunlight/Crandall areas. With the successes of the interoperable communication in other areas of Park County, we recognize how beneficial this service would be

Draft Meeting Minutes

I. Call to Order

The Public Safety Communications Commission (PSCC) met on Wednesday, August 6, 2025, via videoconference. Chairman Monte McClain presided, calling the meeting to order at 8:30 a.m.

IV. Agenda Adjustments

It was moved by Commissioner Waldock, seconded by Commissioner Germain, and unanimously carried to approve the agenda.

V. Action Items

1. <u>Draft Meeting Minutes</u>

It was moved by Commissioner Germain, seconded by Vice Chairman Franklin, and unanimously carried to approve the May 29, 2025, business meeting minutes and the June 5, 2025, special meeting minutes.

VI. <u>Updates/Discussions</u>

1. Director's Report

Director Westby presented the Director's Report.

Legislative Update

Following a brief recess in July, several legislative committee meetings are scheduled throughout August. Director Westby's primary focus during these sessions is educating lawmakers to ensure they fully understand the agency's importance and the necessity of its funding.

Surface Transportation Bill Reauthorization

Director Westby is currently collaborating with the federal delegation on the reauthorization of the federal transportation bill. His primary objective is to secure funding and guarantee that rural states, such as Wyoming, receive appropriate funding allocations. WYDOT's current strategic focus is on maintaining existing infrastructure rather than aggressively pursuing major funding increases, although any additional funding would certainly be welcomed.

Operational Budget

Director Westby reported that WYDOT is working on two budgets: the biennial legislative budget and the annual commission budget. The legislative biennial budget will be presented to the Governor this fall and the Joint Appropriations Committee later in the year.

Outreach and Engagement

Director Westby is actively working to increase the agency's presence across the state to highlight its success stories and reinforce public understanding of the organization's mission, importance, and need for continued support. As part of this outreach, he recently visited Teton County for the ribbon-cutting event celebrating the completed Snake River Bridge project. While there, he also took the opportunity to thank the community for its support during the recent Big Fill Slide reconstruction project.

2. Chief Technology Officer's (CTO) Report

Mr. Smolinski presented the CTO's Report.

Next Generation 911 (NG911) Update

911 Working Group Update

The working group, comprised of Mr. Smolinski, Miss Binning, telecommunications industry representatives, public safety answering point (PSAP) stakeholders, and legislators from the Joint Corporations Committee, has been focusing on three primary areas concerning 911. First, the group is proposing changes to the PSCC structure.

This includes considering one new seat for the telecommunications industry, which will bring the commission up to 14 members. To avoid tie votes, the proposal is to make the Director or their designee a voting member.

The working group is advancing two key proposals to secure necessary 911 funding. The first proposal seeks to establish a specific budget and spending authority for the PSCC, which would be limited strictly to 911-related expenses. The second proposal is to pursue a general fund appropriation to both establish and sustain the NG911 system. While the general fund is the current preferred option, the group is still discussing a potential increase to the existing 75-cent fee. Currently, the working group is focused on analyzing the necessary budgetary numbers and potential costs associated with these various NG911 funding solutions.

The third primary focus is the modernization of 911 fee collection. To streamline this process, the group is pursuing a single point of collection for both post-paid and prepaid fees. The Department of Revenue has proposed language to facilitate electronic filing and establish a central point of contact for quarterly collections and distributions. This system aims to replace the current model—where counties receive frequent, small checks—resulting in a collection process that is more predictable, recordable, and trackable for both the industry and the PSAPs.

The working group is currently preparing to present this and other updates to the Joint Corporations Committee on August 14, with the Wyoming County Commissioners Association (WCCA), the Wyoming Association of Municipalities (WAM), and the Wyoming Association of Sheriffs and Chiefs of Police (WASCOP) taking a leading role, particularly in the funding discussions.

Outage Notification Rulemaking Working Group

The working group is continuing its effort on the rulemaking process for outage notification. This effort involves the same working group members as the 911 update, plus members of the Public Service Commission, which is drafting the rule.

The primary challenge remains reaching a consensus on the trigger for notification, especially given the differing capabilities of large national telecommunications companies versus smaller, local Wyoming carriers. Chairman McClain helped advance the discussion when he clearly outlined the information and timeline PSAPs need during outages. This redirected the conversation away from what data needs to be reported and toward defining the specific event or metric that will trigger the reporting requirement. A final working group meeting is scheduled to conclude this crucial point.

Lumen Update

Mr. Winkelmann provided an update on the Enhance Communications Network (ECN) build-out. While the last information available projected completion by the third quarter, confirmation is still pending before the project can be officially reported as finished.

Mr. Smolinski reported on a significant, multi-day communication outage that occurred at the Lusk Dispatch Center in Niobrara County, affecting the WyoLink connection to

the master site, not the 911 system itself. The outage began around the previous Wednesday and was eventually resolved on Monday morning.

The cause was attributed to a lack of proper communication and procedure when Enterprise Technology Services (ETS) submitted a work order to disconnect one leg of an older circuit for modernization. Poor documentation led to the disconnection essentially terminating the circuit without proper notification.

Extensive staff effort was required from ETS, Motorola, and Lumen, who were contacted late Friday night, to restore the connection, which finally became operational on Monday. As a result, ETS leadership has been mandated to ensure that no circuit is disconnected without a proper procedure in place due to poor historical documentation on legacy systems.

In response to Commissioner Hoff's question about failure notifications, Mr. Smolinski clarified that the WyoLink system has internal monitoring that triggers an alarm if a circuit is down for a set period, preventing false alarms from brief bounces. However, staff often learn about outages first from end-users in the field. For the 911 system, they rely on notifications from the provider and the PSAPs.

In response to Commissioner Kocher's question regarding the recent Montana outage that affected cell-to-landline communication across parts of Wyoming, Mr. Smolinski explained that the PSCC does not typically receive notification for such events. He noted that the outage, which was intermittent and varied by community due to cellular routing, was hard to pin down. The initial notification only listed counties in Montana, where one of the major cellular switches is located, and did not include Wyoming.

Commissioner Kocher shared that the outage prevented cell-to-landline communication for approximately one and a half to two days in Johnson County.

Mr. Winkleman then addressed a related concern regarding maintenance of existing Lumen/CenturyLink copper lines. He clarified that Lumen does still service copper lines in areas where they are the Incumbent Local Exchange Carrier (ILEC). Specifically for 911 services and PSAP infrastructure, if trouble is experienced with copper lines, the first step is to call their operation center at 1-800-357-0911 to open a ticket for investigation.

Chairman McClain expressed a hope that the working group would recommend new rules that create a better outage reporting system for Wyoming. The objective is to define notification triggers that provide information quickly and specifically to affected areas in Wyoming, rather than receiving general outage reports for distant states.

Federal Communications Commission (FCC) Report

Ms. Binning presented the 16th annual report to the commission. Key findings in the report indicate an increase in the overall cost of 911 services this year, occurring concurrently with a decrease in 911 fees collected.

The rise in costs is primarily attributed to numerous Public Safety Answering Points (PSAPs) replacing their radio and phone line recorders, which involved significant capital expenditure. Call volume for the year also decreased compared to previous reporting periods.

All other elements within the report remain consistent with prior years.

GIS Working Group Update

Ms. Binning reported that the GIS work group has applied for the federal Safer Streets for All (SS4A) grant to advance statewide location validation. This project is a partnership with the Enterprise Technology Services (ETS) and the University of Wyoming's WyGISC department, utilizing a portal to test validation fields in Converse, Lincoln, and Park Counties.

The group successfully applied for a secondary grant through the Governor's Office to secure the required \$60,000 local match for the SS4A application. This success is considered a major win, as it resolves the funding issue for the project's next steps by providing the full \$60,000 match, contingent on the approval of the federal SS4A grant. An update on the status of the federal SS4A grant is anticipated around September or October, with more definitive information expected at the next meeting.

State of Wyoming NG911 State Plan

Mr. Smolinski reminded the Commission that a work session, facilitated by Jeremy Johnson of CISA, was held prior to the May meeting to update the strategic plan, a required exercise every four years. The draft plan was included in the meeting packet.

Key changes to the draft involved updating the goals to be relevant to the current 911 environment, adjusting related timelines, and tracking accomplishments from the previous plan. While minor formatting and editorial changes are still needed, the Commission was asked to consider approving the plan in its current form.

Action: It was moved by Commissioner Browne, seconded by Commissioner Carr, and unanimously carried to approve the State of Wyoming Next Generation 911 State Plan.

Local Contracts

Mr. Smolinski reported that WYDOT has successfully secured signed agreements from Converse County, the City of Gillette, Casper, Natrona County, and Teton County. The only remaining county needed to complete the current phase is Laramie County. The goal was to have all agreements finalized by the start of the fiscal year (October 1st), and the department is positioned to meet this target.

3. Emergency Communications Program Manager's Report

Mr. Kelly provided an update on the Emergency Communications Program. The update also included information presented by Mr. Gardiner regarding WyoLink operations.

Mr. Kelly reported that the team is currently focused on completing site and tower preventive maintenance across the state before the end of the fiscal year.

A major upcoming initiative, scheduled to begin in October, involves updating the code plugs in all patrol radios statewide to accommodate the Wyoming Highway Patrol's (WHP) reorganization.

Equipment Donations Update

Mr. Kelly reported that no new equipment requests or field returns have been received since the last report. The current inventory remains detailed in the report in the commission packet and is available to any interested entity. The team has specifically requested that WHP check for any remaining control cables from decommissioned vehicles, as these parts are currently difficult to source.

WyoLink Operational Updates

WyoLink System Reports

Mr. Gardiner shared WyoLink usage data from the second quarter (Q2) of 2025. There was an average of about 1.76 million push-to-talks (PTT) and 147,062 minutes of airtime for the quarter. The top 20 talkgroups for Q2 were law enforcement agencies from 10 counties, three municipalities, two WHP divisions, and tribal law enforcement.

WyoLink System Upgrades

Mr. Gardiner reported that there are currently 97 active WyoLink radio sites, with plans to build additional sites at Needles Peak (south of Saratoga) and Kearns Wildlife Area (north of Sheridan). Construction is underway at the Boxelder site, south of Glenrock, and the Pritchard Pass site in Teton County.

Mr. Gardiner reported that VIKOR Teleconstruction of South Dakota was awarded the bid to construct several new towers. These replacements are necessary because the original foundations were structurally poor at Jade Mountain, Divide Hill, First Divide, Strauss, Shirley, and Sherman Hill. Additionally, remediation work is required at other locations, including Cheyenne Bishop, and the Mount Pisgah tower needs to have more structural steel added. Significant progress has been made on the ground, with Motorola already starting the foundation remediation at Rosette Hill, which is located near Gillette.

Mr. Gardiner reported that significant progress is being made on router upgrades, with 74 sites now on new Juniper routers as part of a conversion to Ethernet. Only 23 of 97 sites are remaining on the upgrade schedule.

The project to upgrade the microwave system is moving forward and is happening at the same time as the effort to replace or repair legacy towers. Mr. Smolinski credited Mr. Gardiner and his team for their hard work and flexibility. The team has been prioritizing and adjusting the work schedule quickly to take advantage of new opportunities, which has replaced the original project plan in order to maximize productivity.

Mr. Smolinski offered to prepare reports detailing system usage during the recent fires outside of Ten Sleep. Specifically, the reports would compare data from the Meadowlark tower and Rattlesnake Ridge tower, which is located near Worland, as their coverage areas overlap. The Commission has two options for delivery: the reports can be sent as a summary immediately following the current meeting, or they can be delivered at the November meeting.

Statewide Interoperability Coordination (SWIC) Updates

Mr. Smolinski provided the SWIC updates.

Cross-State Border Interoperable Communications

Mr. Smolinski updated the commission on the progress of regional interoperability efforts. Initial attempts to establish a communication link with Montana shifted focus to South Dakota, but ultimately found the most feasible path was with Nebraska. This decision was based on the current system versions each state uses for its statewide network.

The Nebraska connection is set up and is undergoing testing. Progress has been somewhat slow because the project team has been pulled in multiple directions with concurrent work. While the necessary cross-state agreements with South Dakota are still pending, a window of opportunity arose to implement a pilot solution focused on immediate cross-border incident response, which was particularly important with the Sturgis Motorcycle Rally taking place.

To immediately improve communication for such events, a high-level solution called the "Interop Talk Group" was implemented. A dedicated talk group was built on the WyoLink system and added to the dispatch consoles for both WHP and Crook County. South Dakota implemented a similar talk group on its state system and multiple bordering counties, including Lawrence County. This talk group acts as a virtual "container": in the event of a cross-border incident, WHP can patch their own local talk group into this channel, and South Dakota performs a corresponding patching action, instantly linking personnel from both states.

The initial pilot involved Crook County, WHP, the South Dakota Highway Patrol state system, and Lawrence County, South Dakota. This effort is a small first step toward establishing full, automatic roaming interoperability across state lines. Mr. Smolinski and the team are happy with the initial achievement, which provides an immediate solution without having to develop extensive policy and technical rules. They expect to have a follow-up assessment soon to review the pilot's performance and determine how to expand the effort. So far, no negative reports have been received.

Motorola Trunked Users Group (MTUG)

Kevin Parker, with Motorola, discussed the benefits of establishing a Wyoming MTUG. The primary benefit is that it is a user- or customer-driven organization strongly supported by Motorola. The structure provides a crucial, direct channel for users to give feedback to Motorola, bypassing typical communication pathways. MTUG chapters are highly influential within Motorola, especially at the national level, meaning a statewide Wyoming group would have a voice in the national organization.

The MTUG format opens up significant opportunities for training that is directly requested by the customers. For example, Mr. Neil Gardner has been invited to present at the Colorado MTUG meeting on August 14 to discuss Wyoming' cross-border connections with South Dakota using the Smart Connect and Critical Connect systems.

Mr. Parker believes that the group will be highly beneficial for all Motorola product users in Wyoming. He hopes to see every PSAP participate in the Wyoming MTUG chapter.

Mr. Smolinski and Mr. Parker are proposing to hold quarterly MTUG meetings in conjunction with PSCC meetings, potentially during education sessions. This strategy aims to optimize members' time and travel by consolidating essential training and user group activities with existing travel commitments, with the training topics themselves being determined by the user group members.

Mr. Smolinski had three primary recommendations for launching a Wyoming chapter of the MTUG. First, he recommended selecting the Level Two MTUG Group membership tier, which allows for a total of ten members (two primary members plus eight others). Second, the membership structure should be a hybrid model, drawing members from the PSCC, specific WYDOT staff, and other individuals as designated by the commission. Finally, to formalize the group, Mr. Smolinski suggested that the commission moved to proceed with developing the Wyoming MTUG at the current meeting. However, the official designation of all members, the selection of the Chapter President, and the final scheduling details be deferred to the November meeting.

<u>Action</u>: It was recommended by staff, moved by Commissioner Germain, seconded by Commissioner Shank, and unanimously carried to establish a Wyoming Motorola Trunked Users Group.

CISA Update

Mr. Johnson expressed thanks to the commission for approving the State 911 Plan. He confirmed he will now work with Ms. Binning to finalize and polish the document. The goal is to produce the final report before the November meeting.

State Markers

Mr. Johnson updated the commission on the "state markers," which are a congressionally mandated self-assessment that are compiled annually by CISA to report on the state of interoperability nationwide. These markers are not a "report card" but a tool that ranks progress as either initial, defined, or optimized.

The current assessment shows an average mark of 2.26, placing Wyoming in the middle nationally. Mr. Johnson stressed that the areas currently ranked as "initial" are not due to a lack of effort by Wyoming, but rather a lack of support from CISA in those specific areas. The purpose of this assessment is to provide data to Congress, which in turn helps determine where federal funding for interoperability should be allocated across the 57 states and territories. The goal is to eventually move all areas to the "optimized" status, but this current picture provides a clear starting point.

The only remaining point was Marker 29, which focuses on developing a PACE (Primary, Alternate, Contingency, and Emergency) plan. The process to update and improve the state's PACE plan has begun. However, Mr. Johnson informed the commission that this will be a long-term effort, likely taking close to 18 months to reach a fully "optimized" status.

Mr. Smolinski then encouraged commissioners to reach out with any questions regarding the report, noting that the dashboard is a snapshot pulled from a much larger, detailed working report. Both Mr. Johnson and Mr. Smolinski expressed their willingness to walk commissioners through the details, and they plan to provide a more detailed progress report on the PACE program at the November meeting.

Action: It was recommended by staff, moved by Vice Chairman Franklin, seconded by Commissioner Carr, and unanimously carried to approve the CISA 25 Interoperability Markers for Wyoming.

VII. Public Comment

There was no public comment.

IX. Announcements

Secretary's Announcements

Ms. Chapman announced that the next meeting will be held in Cheyenne on November 12-13, 2025. Planning efforts are underway for the meeting and education session.

Ms. Chapman and Mr. Smolinski will soon be preparing the 2026 Commission meeting schedule. Ms. Chapman requested that commissioners inform her of any association meetings they need to attend so she can schedule the PSCC meetings to avoid conflicts.

X. Adjournment

It was moved by Vice Chairman Franklin, seconded by Commissioner Kocher, and unanimously carried to adjourn the meeting. Chairman McClain adjourned the August 6, 2025, business meeting at 9:37 a.m.



Accelerating Network Modernization (WC Docket No. 25-208) & Reducing Barriers to Network Improvements and Service Changes (WC Docket No. 25-209)

The FCC proposes rule changes (WC Docket Nos. 25-208, 25-209) to reduce regulatory barriers and encourage providers to upgrade networks to all-IP, promoting advanced communications while safeguarding 911 access. Key proposals include:

- Reducing Regulatory Burdens: Seeking comments on deregulation to encourage network investment. Comments are due 30 days after publication, with replies due 60 days after.
- Copper Retirement/Network Change: Proposing to eliminate filing requirements for incumbent LECs' network change disclosures, arguing it removes unnecessary regulatory burdens. Also considering forbearance from public notice requirements under section 251(c)(5).
- 911 Service Continuity: Emphasizing safeguards (like advance notice) to ensure reliable 911 service during network transitions, addressing concerns about discontinuing legacy circuits.
- Section 214 Discontinuance Process: Reviewing and aiming to streamline the
 process for discontinuing telecommunications services, consolidating the Adequate
 Replacement and Alternative Options Tests into a single, simplified rule for technology
 transitions.
- Replacement Services: Seeking comment on specific services (like facilities-based interconnected VoIP and mobile wireless) as adequate replacements for legacy voice services.
- Targeted Forbearance: Exploring forbearance from section 214 requirements for lower-speed data services (e.g., below 25/3 Mbps) and in scenarios where replacement networks exist.
- Procedural Changes: Proposing to extend the 31-day automatic grant period for discontinuance applications to all domestic carriers, eliminate notification requirements for state governors and the Department of Defense, and streamline emergency discontinuance procedures.
- Outdated Rules: Suggesting the elimination of outdated discontinuance rules (e.g., related to public toll stations).
- **Regulatory Flexibility:** Including an Initial Regulatory Flexibility Analysis aimed at minimizing the economic impact on small entities through simplified compliance.

The goal is to streamline the transition from legacy to next-generation services by reducing regulatory obstacles and promoting investment, without compromising public safety.

RE: FCC Copper retirement rules

Sir-

I have read the FCC Copper discontinuation proposed rule change and have some serious concerns with it at this time. In Wyoming, we often joke that we are ten years behind in terms of technological advancements from the rest of the nation due to our low population and rural/frontier geography.

Currently, Wyoming is in the process of working to start the transition to NG911 from our legacy system. This process is slow as we are working to find funding for the transition and ensuring we are ready to make the switch across the state.

Wyoming is operating on the legacy system with one selective router utilizing CAMA trunks which use TDM technology to cover the entire state. If the LEC provider of our 911 services decides to discontinue the copper line use, we as a state do not have the capability or funding to make a transition off of the legacy system within the time frame the FCC is proposing.

Wyoming as a whole will benefit from upgrades to the aging and outdated legacy system but there is currently no provision or established method to ensure that public safety needs will continue to be met. Right now, all agencies connect via CAMA trunks and therefore there would be upgrades needed statewide to allow for IP based technology to handle the calls.

I can understand the desire to allow telecom providers to move away from copper and be able to reallocate the expense to improving and modernizing their networks via IP technology but as it currently stands, this would adversely affect the public at large and 911 services across the entire state. As our state works towards a NG911 platform, funding the transition, creation and operation is a critical concern and we currently do not have one in Wyoming.

We currently have a surcharge fee that is being used but Wyoming is running at a loss overall and it has been challenging for us to obtain the necessary funding for this. Additionally, this would affect the "carrier of last resort" obligations with the Universal Service fund and existing requirements Wyoming has in place to ensure phone service is available to both low income families and families located where broadband isn't an option.

WYDOT Recommendations for the Wyoming Chapter

The Wyoming Department of Transportation (WYDOT) recommends the following steps to establish and manage the Wyoming MTUG Chapter:

- Membership Bundle: Pursue a Level Two group bundle membership. This bundle
 would optimally include a mix of WYDOT staff and Public Safety
 Communications Commission (PSCC) members, for example, two WYDOT staff
 and six PSCC commissioners, or three WYDOT staff and seven PSCC
 commissioners, depending on roles and needs.
- 2. Chapter Leadership: Nominate and establish a Chapter President. This individual will coordinate directly with the local Motorola Account Executive to develop meeting agendas focused on education, training, and best practices relevant to Wyoming agencies.
- 3. Meeting Schedule: Schedule at least one formal MTUG meeting annually. This meeting should ideally coincide with the PSCC's education session, which is typically held the day before the PSCC's formal business meeting.

We believe establishing a Wyoming MTUG Chapter will significantly benefit our state's public safety and service agencies by enhancing our collective knowledge, improving system utilization, and fostering a stronger partnership with Motorola Solutions.

Wyoming PBS and the Emergency Alert System

Presentation by Joanna Kail, Chief Executive Officer and Josh Williams, Chief Technology Officer

Wyoming PBS plays an essential role in ensuring that emergency information reaches every corner of the state. Through a statewide network of broadcast transmitters and IP-based distribution systems, the station helps deliver messages from the National Weather Service, FEMA's Integrated Public Alert and Warning System (IPAWS), and local emergency management agencies. These systems come together through the state's Emergency Alert System (EAS), which relies on both local broadcasters and statewide partners to keep the public informed during times of crisis.

As part of FEMA's Next Generation Warning System (NGWS) initiative, Wyoming PBS is working to modernize how emergency information is received, processed, and shared. This includes the implementation of a statewide digital messaging system that complements traditional broadcast alerts with online, email, and text-based notifications—extending the reach of critical information and improving public accessibility during emergencies.

At the national level, PBS operates the Warning, Alert, and Response Network (PBS WARN) — a critical backup system that ensures emergency messages can still reach the public when other systems fail. PBS WARN provides a redundant satellite path for Wireless Emergency Alerts (WEA) and other IPAWS messages, allowing cell carriers to continue receiving alerts even if a cybersecurity event or internet outage disrupts their normal connection to FEMA. Wyoming PBS supports this network as part of its statewide operations, maintaining the satellite infrastructure that connects Wyoming to the national WARN system and strengthens the reliability of emergency communications across the region.

Oversight and coordination of the state's EAS plan are guided by the Wyoming State Emergency Communications Committee (SECC), which is recognized by the Federal Communications Commission (FCC). The SECC develops and maintains the Wyoming EAS Plan, establishes monitoring assignments, and ensures broadcasters and cable operators follow federal EAS requirements. By working closely with public safety agencies and broadcasters the SECC helps maintain a consistent and coordinated alerting framework that supports both broadcast and wireless systems.

Through these combined efforts, Wyoming PBS remains committed to its mission of providing timely, accurate, and accessible emergency information to the public—helping ensure that communities across Wyoming stay informed and safe when emergencies occur.

Wyoming State Statute, Title 09 Article 11 Public Safety Communications Commission

9-2-1101 - Commission; created; definitions.

- (a) The public safety communications commission is created.
- (b) As used in W.S. 9-2-1101 through 9-2-1104:
 - "Public safety agency" means any federal, state or political subdivision entity that provides emergency and public safety services, including state agencies employing peace officers enumerated in W.S. 6-1-104(a)(vi)(C) through (F) and approved for participation by the communications commission, fire management services, correctional services, emergency management, emergency and disaster relief services and if desired, county, municipal and federal law enforcement agencies;
 - (ii) "System" means the wireless communications network providing regional and statewide radio communications capabilities to public safety agencies.

9-2-1102 – Commission; composition; appointment of members; removal; terms; officers; vacancies; meetings.

- (a) The commission shall consist of thirteen (13) voting members to be appointed by the governor and who may be removed by the governor as provided in W.S. 9-1-202. The voting members shall be appointed from each of the following associations and agencies from their membership:
 - (i) Wyoming police chiefs association;
 - (ii) Wyoming sheriffs association;
 - (iii) Division of criminal investigation, office of the attorney general;
 - (iv) Wyoming game and fish department;
 - (v) Wyoming department of transportation;
 - (vi) Repealed by Laws 2017, ch. 17, § 2.

- (c) The commission shall elect from its members a chairman, a vice-chairman and a secretary. Vacancies in these offices shall be filled by the commission from its membership. The commission shall meet at least once every three (3) months. Appointments by the governor shall be made within thirty (30) days of expiration of membership terms. Nominee lists shall be furnished within ten (10) days upon expiration of any membership term. Each member shall serve a three (3) year term. A vacancy on the commission shall be filled for the unexpired term by the governor.
- (d) The person appointed to the commission pursuant to paragraph (a)(v) of this section shall be the chief technology officer of the Wyoming department of transportation or another employee of the Wyoming department of transportation who oversees information technology or telecommunications systems.

9-2-1103 – Commission; compensation of members.

Members of the commission shall receive mileage and per diem provided state employees.

9-2-1104 – Commission; powers and duties; advisory capacity to promote system development; public meetings; clerical and administrative support.

- (a) The commission shall:
 - (i) Work with the state budget department, the department of enterprise technology services, the department of homeland security and the department of transportation in an advisory capacity to promote the development, improvement and efficiency of public safety communications systems in the state;

- (ii) Report in writing each year to the governor and the joint transportation, highways and military affairs interim committee concerning any problems related to the installation, operation and maintenance of the system and shall make any recommendations it deems appropriate as a part of the report;
- (iii) Submit a plan for statewide system networking to the department of enterprise technology services for inclusion in the statewide telecommunications plan developed pursuant to W.S. 9-2-2906(g);
- (iv) In cooperation with participating federal agencies, establish and assess user fees upon any federal law enforcement agency electing to use and participate in the system;
- (v) Promulgate necessary rules and regulations governing system operation and participation and upon failure to comply with adopted rules and regulations, may suspend system use and participation by any participating and noncomplying public safety agency or private entity;
- (vi) Determine the participation of public safety agencies and private entities in the wireless communications network:
- (vii) On or before May 31 of each odd numbered year, submit to the governor and the joint transportation, highways and military affairs interim committee a report covering the period beginning July 1 of the following year and ending June 30 in the fourth succeeding year detailing the expected costs of implementing the statewide system networking plan. The report shall include projections of one-time and recurring costs;
- (viii) Recommend guidelines and standards for the development, implementation and operation of next generation 911 emergency communications systems and interoperable public safety communications and data systems in the state, including strategies for improving Wyoming's current 911 system. As part of the recommendations developed under this paragraph, the commission may identify short-term and long-term technological and policy solutions that integrate existing legacy communications infrastructure into an interoperable system and may develop and submit recommendations for legislation or other state action to further develop and support next generation 911 operations in Wyoming;
- (ix) Promulgate necessary rules and regulations governing next generation 911 system operation and participation.
- (b) The commission may hold public meetings throughout the state and may take other appropriate measures to maintain close liaison with regional, county and municipal organizations and agencies involved in the system.
- (c) Necessary clerical and administrative support for the commission shall be furnished by the Wyoming department of transportation.
