It was recommended by Mr. Collins, moved by Commissioner Hladky, seconded by Commissioner Dziardziel, and carried that **Intermountain Construction and Materials, Inc., Gillette, Wyoming**, having prequalified in accordance with rules and regulations adopted by the Transportation Commission of Wyoming, be awarded the contract as low bidder. The Federal Highway Administration concurred with this decision.

Mr. Collins explained that JWright Companies' bid was deemed irregular because, although the electronic copy of the bid was complete, the hard copy was missing two pages. JWright provided the missing pages after the bids were opened. The pages merely did not print out. Mr. Collins read an excerpt from the WYDOT Standard Specifications for Road and Bridge Construction, reciting that the Commission has the prerogative to reject any and all bids based on the omission from the bid.

JWright provided the Commission with 13 pages of documentation before the meeting, which supported their bid. Mr. Wright's cover letter stated that, "the missing pages do not affect the bid amounts used in the low bid selection process," nor do the missing pages affect the prices set in the total bid.

Mr. Collins indicated that the missing pages were not considered a fatal flaw and, therefore, he recommended conditionally awarding the project to JWright Companies. Conditions of the award

were that JWright must provide the Department with a cover letter stating that they will fulfill the bid requirements, and they must provide signed and dated hard copies of the missing pages. Furthermore, upon receipt of these documents, executive staff would be given the authority to award the project to JWright Companies.

It was recommended by Mr. Collins, moved by Commissioner McCormick, seconded by Commissioner Ertman, and carried that **JWright Companies, Inc., Evanston, Wyoming**, having prequalified in accordance with rules and regulations adopted by the Transportation Commission of Wyoming, be conditionally awarded the contract as low bidder, in accordance with the above stipulations. The Federal Highway Administration and the City of Cody concurred with this decision.

Mr. Wright thanked Mr. Collins for his explanation of the situation, and thanked the Commission for their support of Mr. Collins' recommendation. Mr. Wright advised that JWright will stand behind their bid and will meet the conditions of the award.
