We are planning to send out a *Customer* Satisfaction Survey in August, and we hope that you will take the time to share your opinions with us. 

### Yet Another Electronic Signature Update

In our effort to continually keep you updated on the ongoing project known as the Electronic Signature project, we offer the following:

As you've all come to appreciate over the past twelve to eighteen months, this project now entails much more than an electronic signature process. While the impetus was to create the ability for us to accept electronically submitted coversheets (through the use of an electronic signature), the project has expanded to not only create a more expeditious, more userfriendly electronic filing process, but to ultimately create a "one-stop-shop" for our customers where you can upload your monthly reports and any supporting documentation. complete the coversheet information, sign electronically, and pay any taxes due.

The project appears to be in the home stretch as our IT and Financial groups are finalizing the details related to the "Pay Now" process. As we understand the process, customers will have two options when they select the "Pay Now" button after uploading their files: 1) Pay a tax liability of up to \$250,000 online through an e-check process; or, 2) Sign-up for the ACH/EFT/Wire Transfer payment processes. You will still have the third option of mailing a

check if that is the process you prefer. Again, this was a lynchpin process for us that we thought was worthy of delaying the implementation of the entire project, and we anticipate that it will all have been worth the wait.

Our most recent estimation was that we would be transitioning to these new processes in mid-August 2018, but due to the external processes necessary for the "Pay Now" options we are now anticipating a firm rollout date of November 1st, 2018.

The "home stretch" referred to looks like this: We anticipate another round of testing of the filing and payment processes late August through mid-September. We then anticipate a period of time to resolve any issues, re-test if necessary, and then a "clear the pipe" timeframe estimated to be about 14 days in the middle of October. We anticipate a "quiet period" in October where you will not be able to upload any files, and this is done so that the new code can be moved into place. We will continue to refine these details over the next few months, and we plan to formally communicate the details to each of you as we get closer. Unfortunately, the statement has to be made that this is all subject to change, but everyone

involved is pushing to get this project across the finish line by November 1st.

Again, prior to the transition, we need to ensure that we have received all required documentation from our customers. Several months ago we sent Electronic Signature **Trading Partner** Agreements to all customers, and we have received the majority of them back. If you have not vet submitted the **Trading Partner** Agreement, please return it to us as soon as possible as a signed agreement will be required for you to file electronically in the new system.

**EDI Filers:** Please remember that there are new EDI specifications that will need to be employed when this process goes live. Until then, you will need to continue using the current EDI specifications. The new EDI specifications are posted on the FTA website in two formats: One format is simply the proposed new EDI specifications, and the other format highlights the actual changes to the EDI specifications.

Again, we plan to provide more detail about the new processes as we move ever closer to implementation, and as always we thank you for your patience.
