Getting Caught-Up In FTA

Well, while we're interested in breaking records here at FTA, the record for the most delinquent newsletter is not one we're proud of! Once again, please accept our apologies for the delay in getting the newsletter out to you, but you will no doubt see that we've had a lot going on over the last four to five months.

Things are looking up here at FTA as we continue to move the needle and get closer to what we consider "being current." While we have experienced a recent loss of institutional knowledge with the retirement of Jan Hertel, we have done our best to keep the team crosstrained so changes such as these would be seamless to our customers. Learning is a daily activity in FTA, but our team has become more experienced, thus more effective and efficient, and therefore we are closing in on having the account work "current." While we are pleased with this progression, we are painfully aware that we don't consistently keep all of the balls in the air and that some things are still slipping through the cracks. This awareness will keep us focused on improvement, and for those of you that have experienced this through bad information, lack of follow-through, etc. we sincerely apologize.

Along the lines of auditing, we have received a good amount of feedback that our customers view having the same FTA Tax Examiner working their account over a period of months as a favorable shift in our process, and we believe it is a positive change as well. We continue to hope that the familiarity will breed some increased consistency, and that the

business relationships that are formed will improve communication between our team and the customer group. As we've shared in the past, we will rotate the accounts periodically to avoid what we refer to as "tunnel auditing," but we intend to "cross-pollinate" which should result in a fairly seamless transition between Tax Examiners.

Legislatively, the 2017 legislative session was certainly another challenging one for Wyoming legislators and State of Wyoming agencies. From a fuel tax perspective, the only applicable piece of legislation was SF 0023 which was related to fuel tax appeals. Wyoming fuel tax statutes did not allow for appeals of three or one year audit findings, and the Wyoming Board of Equalization, industry, and FTA thought this was something that should be addressed. Ultimately, the Wyoming Legislature and the Governor of Wyoming agreed, and the law goes into effect on July 1, 2017. The Wyoming Board of Equalization worked with FTA and took the lead on the drafting of the bill. Both the BOE and FTA testified in favor of the bill during the legislative session. Now, the Board of Equalization will work with FTA to craft rules and regulations relating to the fuel tax appeals process, and at some point in the future those rules and regulations will be open for public comment.

It's now getting to the time of year where travel across Wyoming and surrounding states is a little easier, so FTA will be out visiting customers during the summer months, to help with reporting, electronic filing, etc.



Jan Hertel Retires From FTA

The Fuel Tax Program lost a valuable member of the team and a great deal of institutional knowledge several weeks ago when Jan Hertel retired. When Jan announced her retirement, we had mixed feelings of joy for her and sadness for us.

Jan began her career as a temporary Financial Specialist with FTA in June 2005. She became a permanent employee with the FTA Program in October of that year, and there was no looking back as Jan was hooked. Electronic Signature Update

The electronic signature project continues to move forward, and we are really hoping to be testing the new processes in the next four to five months. While it seems like it has been a long development process, the outcome is going to be a complete electronic solution that should make monthly filing easier.

The WYDOT IT Team continues development on the site where customers will drop their electronic files, complete the coversheet, attach other relevant documents, and electronically sign to submit their monthly fuel tax return.

Once testing is complete, FTA will send a cover letter with an electronic filing form. Once the form is sent back to FTA, the customer will receive an email containing the user name and temporary password. While the details are still being worked-out, we believe this is very close to how the process will work.

We now know that this version will not have the option to "pay now," but that option remains on the drawing board for future development. Please remember that you can currently set-up ACH payments.

More news to come in the very near future. We are excited about this new application becoming reality.
