Purple Heart Recipient: Documentation that applicant is an official recipient of the United States Military Purple Heart Award. Prisoner of War: Documentation that while serving in the United States Armed Forces, applicant was incarcerated by an enemy of the U.S. during a period of conflict with the United States. POW's are exempt from registration fees for one (1) truck, car or motor home. Additional POW plates may be obtained by payment of registration fees.
