STATE TRANSPORTATION IMPROVEMENT

PROGRAM FY-2022 2nd QUARTER UPDATE

This report provides a summary of all added or dropped projects during the 2nd quarter of FY 2022 (Jan, Feb, and March) that have been approved by the transportation commission. The projects are shown under the county they reside. The general/detail location, linear referencing system (LRS) ID, and reference marker (RM) limits provide a depiction of the project location. Other project-specific information is shown within the tables such as the project prefix, transportation commission district where the project resides, character of work, and fiscal year the project is planned for construction. Additionally, the remarks field identifies the monthly commission meeting where the project was approved and what phases of the project were approved. Under the cost column, the phases are abbreviated as follows: Preliminary Engineering (PE) which is the design phase, Construction Engineering (CE) which is the contract administration of the construction, and Construction (CON) which is the estimated cost to build the project. These totals are further bracketed into Federal, state, and other funding amounts.
